We are pleased to present to you our 2018 annual report, which summarizes the highlights of Fiscal Year 2018. This year we made great progress in meeting two of the major challenges in health care today: providing rehabilitation services aimed at recovery of the whole person and enhancing the quality of life of residents who want to live life to the fullest.

Our dedicated staff worked with individuals with a wide range of complex needs related to joint replacement, orthopedic injuries, heart and lung conditions and strokes. In addition to the latest physical, occupational and other therapies designed to facilitate mobility and function, the staff provided art, music and other activities to help individuals heal emotionally.

To care for individuals with medically complex needs, our historic structure is being transformed to accommodate the latest technology and facilitate ease of treatment.
